Feb. 3, 2011 Meeting

Meeting called to order at 7:00 pm
Present: Scott, Lori, Steve, Paul, John

1. Dec. meeting minutes were approved with a motion by Paul and a second by John. (There are no Jan. 2011 minutes as we do not meet in Jan.)
2. There was no Nature Parks & Trails meeting tonight, so no update. Lori did pass out a note regarding the public hearing on the county park (Feb, 9) and that we should send emails to show our support.
3. Ball Program: Steve will be the Summer Rec Program Coordinator again this year – Thanks Steve!!! Registration for the ball program will be held at City Hall on Saturday March 26, from 8:30-10:00am. Steve will check into other area cities fees, and we may raise our registration fees. It will include a T-shirt that the player keeps. Umpires will be paid by the city \$25.00 per game this year. Advertising will be done for umpires and concession stand workers. The concession stand bathrooms will be updated in spring with new fixtures, paint, and seal cement floor.
4. We did finally receive the Thursday night Men's League fees.
5. Paul informed us that the DNR has a grant for youth programs. Maybe we could use this for mowing or concession stand workers? Any help from their Youth Conservation Corp could be helpful to us, and save us some money.
6. There were 3 Rockfest Committee members present at our meeting. They might be using the SB field for a kickball tournament. We will again sponsor the Kiddie Tractor Pull. The bars were in charge of the street dance last year, but this is undecided yet if they will be again. The bars would probably also coordinate the kickball tourn. The dance location is still uncertain – as we would prefer to not have any heavy equipment or trucks on the field. The whole festival will start a little later this year – probably Noon or 1:00pm. They want to use the bleachers again for spectators at the events. There may be Hula Hoopers, or Lumberjacks. The theme is: Clowning Around Rodeo Style
The date for this years event is Sat. July 9, 2011.
7. Lori gave a summary of Santa Day (which is attached to the Dec. 2010 meeting minutes). Overall it was a success, but with less kids this year (75). Kids enjoyed seeing Santa, getting great pictures taken, playing some games, and seeing the fire trucks.
8. The warming house in Comm. Park is now closed & locked due to vandalism.
9. Paul has been working on getting measurements and a supply list to replace the boards on the hockey rink in Comm. Park. He had 2 bids on the lumber so far. Treated lumber will be used. We fine tuned how we would like it built and the supply list, and now he will get 3 quotes and then we can present it to the council for approval. He also has STS (Sentence to Serve) committed to this project for spring. Paul has also looked into some grants that could be used. He will apply for the DNR one. Thanks Paul for all your work!!

10. Some money has come through for rain gardens. The city would like to put 3 of them in at Lions Park. We will need to get volunteers to help put them in, and to help maintain them. Put this in the next newsletter, as this should be done this spring/summer.
11. Our parks and playgrounds have not been routinely inspected. The city is checking into this with the insurance company.
12. Sat. Feb 19th is the Polar Plunge for Special Olympics, to be held in front of the 400 Club. John is planning for the parking for this event. He would like to remove the snow in a large section of the park. This would be done with a blower instead of a plow to help prevent damage to the grass. We agreed this would be fine.
13. The Easter Egg Hunt for 2011 is being planned for Sat. April 23rd at 10:00am.
14. We really could use another member on our board. Scott suggested we give a brief summary of our meetings to be put in the Cold Spring Record each month. Maybe this would help promote some interest to people reading the Rockville section.
15. We briefly went over the 2011 approved budget.
16. Motion to adjourn by Lori, with a second by Steve.

Meeting called to order at 7:00 p.m.

1. We started our meeting by setting up an assembly line and put together the 144 registration bags for Santa Day. We had some representatives from Kohl's here to help us do this, as part of their grant to the Lions Club. If we would need more we will make them up that day with any extra items we have left. The balance of the spring Target donation was used up for Santa Day bag treats.
2. Following this we conducted our regular meeting.
3. The Nov. meeting minutes were approved with a motion by Steve, and a second by Paul.
4. The pavement has been removed from the Community Park hockey rink. This rink needs new boards. Sentence to Serve could do the labor to install them if we get the materials. We will check into some prices. The city maint. dept. has started to flood the rink, but Steve will try to find some volunteers to do this.
5. Another idea, now that the tar is out, is to put sand in there and in the summer we could put up a volleyball net. Then this could be used year round.
