MINUTES OF 07/24/12 -

Motion by Member Willenbring, second by Member Karls, to approve the minutes of 07/24/12 as presented. Motion carried.

ADVERTISING SIGN – Don Simon had presented a request from George Bechtold who wants a sign put up leading people to downtown. The cost of the sign proposed is \$48,000 OR \$18.03 per capita.

President Salzl reported that he spent \$200/mo or \$2400/yr to have the Franklin Sign available for city businesses to advertise on and that did not happen.

Member Willenbring reported that Lumber One wanted to rent the sign but was told they could not due to city ordinance.

Also discussed was land where the sign could be placed if purchased. Fire Hall is too far from the highway to be seen and there will be issues with programming as there is so much granite between city hall and the fire hall. The city experienced problems already for this reason.

Other options are the Jeff's Freedom Auto sign, contacting the State of MN for their sign.

Motion by Member Willenbring, second by Member Karls, to have Don Simon carry the message back to Mr. Bechtold that more research needs to be done first so action is tabled at this point. Motion carried.

REVOLVING LOAN FUND POLICY - Heidi Peper had provided the board with the following documents for consideration:

Supplemental Loan Agreement

Member Willenbring questioned the following on the Revolving Loan Fund -

II E The project will create or retain jobs that pay an <u>average of \$12.00 per hour in wages and</u> benefits.

III C Wages paid to employees $\underline{\text{must be at or above}}$ \$12/hour plus benefits These two should say the same thing.

III E The EDA may waive job requirements at its discretion for commercial rehabilitation projects if a building has been identified to be in a blighted condition. He has heartburn with this and how it will be handled.

IV D The City may provide deferments on principal repayments and subordination of loans to meet the credit needs of borrowers.

Are we giving out freebees?

IV H There is a base application fee of \$100, a charge a one percent (1%) Missing the word "of"

IV C Interest rates are 2% below the prime rate, minimum of 3% Are rates lower than that now? When is this adjusted?

IV B Loan terms – should be kept low

IV E 10% of project costs – they should have to put down 20%

Member Becker indicated that the \$25,000 maximum is too much.

Member Willenbring stated this is only a bridge loan if we are close. This should only be for a short period of time.

Rena Weber suggested that she gather information from other cities and find out from them what worked – what didn't. These questions will be discussed with Heidi at the next meeting.
