## Notice of Hearing on Proposed Re-Assessment

### TO WHOM IT MAY CONCERN:

Notice is hereby given that the council will meet at 6:30 p.m. on, June 18, 2014 at Rockville City Hall – 229 Broadway Street East, Rockville MN to adopt, the proposed Re-Assessment for Kenn Tamm. The Adoption by the council of the proposed Re-Assessment may occur at the hearing. The following is the area proposed to be assessed: Parcel #76.41720.0443

The amount to be specially assessed against your particular lot, piece, or parcel of land is \$838.48. Such assessment is proposed to be payable in eight (8) installments, the first of the installments to be payable on or before the first Monday in November 2014, and will bear interest at the rate of 4.34% percent per annum from the date of the adoption of the assessment resolution. To each subsequent installment when due shall be added interest for one year on all unpaid installments.

The proposed assessment roll is on file for public inspection at the city clerk's office. The total amount of the proposed assessment is \$838.48. Written or oral objections will be considered at the meeting. No appeal to district court may be taken as to the amount of an assessment unless a written objection signed by the affected property owner is filed with the municipal clerk prior to the assessment hearing or presented to the presiding officer at the hearing. The council may upon such notice consider any objection to the amount of a proposed individual assessment at an adjourned meeting upon such further notice to the affected property owners as it deems advisable.

An owner may appeal an assessment to district court pursuant to Minn. Stat. § 429.081 by serving notice of the appeal upon the mayor or clerk of the city within 30 days after the adoption of the assessment and filing such notice with the district court within ten days after service upon the mayor or clerk.
